DISCIPULUS News

Clinicians today are expected to keep up with current knowledge on some 10,000 diseases and syndromes, and over 1000 medical tests. There is a risk that the ever-increasing body of information within biomedical science will cause information overload. This includes patient data, clinical trial data, longitudinal studies and research data. For example, in 2008, there were 18 million papers in the biomedical science literature, and the annual number of papers being added to this is expected to exceed 1 million this year. Clinicians are also struggling to effectively treat patients suffering from multiple, interconnected and long-term diseases.

Physiological modelling offers the potential for making sense of vast interconnected sources of data. At the simplest level, they can highlight correlations with statistical models, while at the most complex they can accurately simulate the mechanisms of action of diseases and treatments.

The Digital Patient will bring to bear the vast tools of information and physiological modelling on the information overload encountered in healthcare. It will absorb information of all relevant types and translate it systematically into knowledge: about what treatment may be best, about planning the treatment, and about understanding the phenomena themselves. The raw materials for the Digital Patient will be information. This is no small matter, as the information currently available is fractured, incomplete, and not standardised. In fact, patient data may always be relatively incomplete, and our challenge will be to build robustness for this type of information.

The Digital Patient initiative will tackle three key levels of information handling: Access to information (i.e. how it is interacted with, manipulated and visualised), Information blending (where several information sources may be combined to produce entirely new, second generation information), and the 'knowledge avatar' (where information is translated into usable knowledge on patient physiology and treatments). This project represents a new and exciting approach to healthcare information handling. There are many challenges ahead, and indeed, we may not thought of all of them yet.
